1 Introduction

The SUDOSCAN device is powered by the Windows 7 Embedded SP1 operating system.

1.1 Patent

The SUDOSCAN[®] device is covered by U.S. Patent No. 8665443 and 8918170, entitled "Electrophysiological analysis system and method". The SUDOSCAN trademark is protected by U.S. Trademark Registration 11/922812, owned by Impeto Medical.

1.2 Use

The SUDOSCAN device is a medical device for Galvanic Skin Response assessment to aid in the evaluation of sudomotor function. The SUDOSCAN device is indicated for use in the general adult population.

1.3 Principle

SUDOSCAN measures the capacity of the sweat glands to release chloride ions in response to an electric stimulus. It is a dynamic test equivalent to a stress test.

Description:

The SUDOSCAN device consists of the following:

- A control panel and display
- A pair of foot smart docks and smart electrodes
- A pair of hand smart docks and smart electrodes
- A power cable

1.4 Installation

Carefully follow instructions in the corresponding manual to ensure correct installation.

Complete installation should take no more than 15-20 minutes.






Figure 1 : Home page – no user is logged in



5.2 List of controls




Figure 5 : Quality Check page – Empty

1	Click on the hands (left) and feet (right) <u>Electrode test</u> buttons to check the connectivity of the electrodes. The appropriate electrode LED will light up if the connectivity is Ok.
2	 Enter an <u>Operator name</u> to be displayed in the Quality Check report. If the Operator name is not set, the Physician's name is displayed in the Quality Check report by default.
3	Click on the <u>Run test</u> button to launch a full Quality Check sequence (<i>ref. p14 for Quality Check results interpretation</i>).

NOTE

The Quality Check must be performed as a stand-alone test without any contact on the electrodes.




Figure 12: Configuration page - Additional controls for supervisor


You can select several types of data:

- <u>Compile and export a CSV file:</u> including all data for the selected exams. The encryption of patient names is optional (reversible, irreversible or none). Stored within the /CompiledCSV/ folder on the USB key.
- <u>Export Raw files:</u> These are the raw data files export, useful when switching from one Impeto system to another. Stored within the /ExportRaw/ folder on the USB key.





7.3 What if the scan cannot be launched?

- Please check that the docks are correctly plugged in the system and reboot the system.



7.4 During the scan

1 The application displays a video and a progress bar during the scan. With smart electrodes, the scan progression is also described by the LEDs that are lighted progressively, from bottom to top, on each docks (hands and feet).



Calibration is performed at the beginning of each scan. The patient is asked to remain still during the scan.



2 If hand or foot contact on the smart electrodes is lost during the calibration, an error message will appear on the screen.



- 3 The scan can be cancelled at any time by selecting the <u>Stop scan</u> button.
- 4 Scan completion is confirmed by a double-bell sound (unless the volume is muted).
 - Upon successful completion of the scan, the scan number (#) will increase by 1 and the remaining scans for the smart electrodes will decrease by 1, as shown in the upper right hand corner of the screen.
 - The results page is displayed once the scan successfully ends (ref. p46).
 - If the scan ends with an issue, the application proceeds to the results page but the remaining scans will not decrease by 1, except if the scan is validated by the user (ref. p47)
- 5 Desinfect the electrodes after each scan with the manufacturer approved cleaning solution and Kim Wipes (KIMTECH Science Brand)(*ref. p53*).




Figure 18 : Patient History page






Figure 20: Display results for an exam





9.2 Results

The SUDOSCAN device immediately populates results after a scan. The measured conductances are displayed on the screen. Test results provide a measure of Galvanic Skin Response for each extremity, and a measure of sudomotor function. Results are expressed as skin conductances measured in micro Siemens (μ S). Results should be interpreted by a physician, taking into account the patient's clinical history.


9.2.1 Asymmetry

Asymmetry for hands and feet is computed using the following formula:

$$Asymmetry = \frac{(Left \ Electrode \ Conductance - Right \ Electrode \ Conductance)}{\max(Left \ Electrode \ Conductance, Right \ Electrode \ Conductance)}$$

9.2.2 Quality of Measure

If the patient moves during the scan, the following message appears on the screen:



The user is given the opportunity to accept the results or re-scan the patient. Selecting <u>Accept</u> will allow the current results to be saved within the patient's follow-up. The report will be generated with a note stating that the patient moved during scan and that results may be compromised.

Selecting **<u>Re-Scan</u>** will return the user to the scan page to start a new scan.


NOTE

When performing a Re-Scan, the number of remaining scans will not be decreased unless the user accepts the scan results with the observed error or the scan is performed anew.

NOTE

Electrodes must be disinfected before re-scanning the patient with manufacturer approved disinfectant and Kim Wipes.

During the scan, if the following image is observed, then the patient is either grounded (touched during the scan) or an internal issue may have occurred.









Figure 26: Add comments on reports



11 Disinfecting the electrodes



Immediately after each scan, it is important to clean all smart electrodes with the manufacturer approved cleaning solution and Kim Wipes (KIMTECH Science Brand).

This will not only disinfect but also neutralize the electrochemical reactions which have taken place on the smart electrodes during the scan. Additionally, this stops the corrosion process which would otherwise quickly damage the electrodes' surface.



- 1 Deposit only a small quantity of cleaning product on each electrode.
- 2 Wipe the electrodes with Kim wipes until dry.



Strictly adhere to the cleaning solution's instructions for use.

12 Replace the electrodes

Before launching a scan (*ref. p32*), the number of available scans appears on the top right header of the program screen. The scan number (Scan#: XX) will increase by one and the remaining scans (Remaining scans: XX) will decrease by one upon successful completion of a scan.



Once you have received a new set of smart electrodes, follow the instructions to replace them:

1 On the underside of the electrode dock, loosen the locking screw and hold it down.






Figure 31: Issue with the smart electrode dock.

18 Precautions for use and technical specifications

Principle of the SUDOSCAN device

A low DC voltage is applied to electrodes in contact with the hands and feet, areas with the highest sweat gland density. The electrical current stresses the sweat glands which, in response, release chloride ions (Cl-).

At low voltage, the stratum corneum acts as a capacitor and only the sweat ducts allow the transmission of ions from the skin to the electrodes. This ensures that the measurements taken correspond solely to the sweat gland function.

There is an observable electrochemical reaction between the CI- ions and the anode.

The device records the electrochemical conductance related to the concentration of the chloride ions from the sweat glands and detected by the electrodes (on the hands and feet).

The SUDOSCAN device is composed of the SUDOSCAN software integrated into a touch-screen Windows 7 PC computer and connected to 4 electrodes for the patient's feet and hands.

General operation of SUDOSCAN

The patient positions his/her bare feet on the feet electrodes, and applies the palms of his/her hands to the hands electrodes.

After entering the patient demographic information (last name, first name, age, gender, height, weight), the operator will initiate the software and activate the electronic circuitry of the device, which will then apply DC voltage to the electrode and will measure the current passing through the electrodes.

Several successive cycles of measurements are carried out automatically and all the measured values are recorded on the hard disk. Data processing is then performed to compute the conductance on each smart electrode.

At the end of the measurement cycle, which lasts approximately 3 minutes, the user can see the displayed patient report on the screen and also has the option of printing out a hard copy of the report. No control is accessible to the patient, and the use of the SUDOSCAN system is strictly reserved for physician use in a healthcare setting.

Precautions of use and maintenance

Transport

If it is necessary to pack, transport or deliver SUDOSCAN after its use, it is recommended to use the original packing box and arrange all its elements in their housing and position of origin.

Pay particular attention to carefully arrange the smart electrode dock cables in the locations especially designed for them in the protection foams so as not to damage or weaken them.

The SUDOSCAN box can be stored upright or laid down. The SUDOSCAN device does not contain any capacitor element.



At the end of its lifetime, the SUDOSCAN device must be returned to **Impeto Medical**'s authorized distributor, which will return it to **Impeto Medical**, in order to ensure the recycling of certain components.

The components and the accessories of the SUDOSCAN device are free of mercury and of components containing this element.

Protection against moisture



Do not use the SUDOSCAN device in a wet or damp environment.

The SUDOSCAN device is not protected from the effects of the discharges of an external defibrillator, nor against high frequency currents or strong electromagnetic disturbances. The use of mobile telephones or wireless fixed telephones can cause signal disturbances.

Electromagnetic compatibility



The use of portable and mobile RF communication devices (for example: cellular telephones) can influence the analysis carried out during the recording, as the recorded signals can be disturbed by electromagnetic interferences.

The device should not be used in the presence of ionizing radiations (x-rays, gamma rays ...) because those could erase the internal storage.

For the tables concerning the electromagnetic emissions and the immunity of the recorder, see the appendices of this handbook.

Maintenance of the device and electrodes

No particular maintenance is necessary.

The external case and the cables of the electrodes can be cleaned using a slightly wet tissue or soaked with soapy water. Do NOT use any detergent product, alcohol or acetone.

To avoid corrosion and ensure the best conditions of hygiene, the feet and hands electrodes must be cleaned immediately after each patient with an Impeto Medical approved cleaning solution.



ONLY PERSONNEL AUTHORIZED BY IMPETO MEDICAL IS ALLOWED TO PERFORM ANY REPAIRS OR MAINTENANCE ON THE DEVICE (MAINTENANCE, CALIBRATION, ETC.).

All the technical documents (component part lists, descriptions, calibration instructions) are kept by **Impeto Medical**.

The warranty will be null and void if the SUDOSCAN device is opened and repaired by any unauthorized person. Warranty will hold only against manufacturing defects and certainly not for any mechanical damage due to mishandlings or misuse. Refer to manual for proper use of the equipment.

Use and storage conditions

- Do not block the vents
- Do not use the device in a dusty environment
- Do not use the device in an oxygen-rich environment, with vapors or inflammable gas
- Keep the device away from any flammable source
- The device is not intended to be sterilized
- Use the device inside
- Use the device in a dry environment
- Maintain a minimum distance of 20 cm around the master unit



Use of the electrodes

To ensure high quality recordings, particular care must be taken with the preparation of the skin of the patient and the installation of the electrodes.

It is also advisable to verify the smart electrode dock cable connectors are well inserted into the corresponding sockets at the rear of the SUDOSCAN Master Unit.



USE ONLY THE ORIGINAL ELECTRODES PROVIDED BY IMPETO MEDICAL.

Impeto Medical cannot guarantee the results of measurements carried out with electrodes issued from other manufacturers.

When it is not in use, the SUDOSCAN device can be stored without disconnecting the smart electrode dock cables.

Positioning on the electrodes

The patient must position the sole of his bare feet in the center of the feet electrodes and firmly apply their hands flat in the center of the hands electrodes.

Except in the event of significantly overweight patient, all scans should be performed with the patient standing upright on the feet electrodes.

Interrupting or stopping the measurement

The test will automatically stop at the end of the measurement cycle, after approximately 3 minutes.

To stop the test BEFORE the end of the measurement cycle, select the <u>Cancel</u> button during the scan.

Recommendations to the operator

As with any medical examination, it is recommended to check the environmental conditions and the condition of the patient before carrying out a measurement:

- Room temperature is between 65 and 95 degrees Fahrenheit,
- Cardiac holter measurements going on can be altered during the 2 minutes time scan.

Contra-indications



The repeated use of the SUDOSCAN device does not create any side effect. However, it is advised not to proceed with measurements on the following patients:

- People with any open or bleeding wounds that would come into contact with the surface of the smart electrode,
- People with missing limbs,
- Pregnant women or women who are uncertain about a possible pregnancy.

Calibration

The SUDOSCAN device auto calibrates at the beginning of each test. The auto-calibration ensures that each smart electrode has enough contacts to proceed with the measurements.

If the calibration is interrupted, the operator is informed by an audible bell sound and/or an error message.
